# ATLAS Workbench Comprehensive List

## *What is an ATLAS Deliverable?*

ATLAS Deliverables include final documents, data, and/or files that are required to be uploaded into the NCDOT's ATLAS Workbench web application. Not all ATLAS Deliverables are required on all projects. The NCDOT PM (Central, Division, or Technical Unit PM) will determine required work based on project scope and screenings. Files uploaded to ATLAS must follow the ATLAS Standards.

When you upload a file to ATLAS, ATLAS *automatically* saves the file to the project's Scoping or Preconstruction project site. Uploading these files to ATLAS ensures that files are saved with the correct naming convention and correct metadata and key document tags are assigned in the project record.
