#### Version 5.5.2 of ETRACS (10/25/2017) [build 5.5.2] includes:

A new sort order is assigned to dropdowns in ECAP request. The source of the milestone list is now displayed to the user on the dashboard and at Update Project. Changed the order of date on ECAP request on View and Update.

More detail:

- Milestones are now synchronized with SAP.
- Report parameters have been redesigned to allow user to filter by county, division, region and the TIP number has been changed to a drop down box.
- Bug fixes including the planning date calculation and project deletion and the saving of certain data that was greater than the limit.

### Version 5.5.1 of ETRACS (9/24/2017) [build 5.5.1] includes:

A new sort order in transfer projects, new rules regarding transferring requests have been implemented and a fix for scrolling bug that prevented a button from being displayed.

More detail:

- Fixed issue with Transfer Request where a long list of requests was not permitting the Transfer button to be displayed.
- Change the sort order of Projects in Transfer Project to be by WBS#.
- In Transfer Request, changed the requestor assignment to allow the To-requestor to be the same as the old requestor thus allowing changes to the On-Behalf of.

### Version 5.5.0 of ETRACS (8/30/2017) [build 5.5.0] includes:

A way to allow an admin to transfer the requests, by all or by some, from one project to another has been added to keep projects in sync with STaRS.

Also:

- User sync with NCID – when a user is updated in NCID – for example, their name or email changes, ETRACS now allows the administrator to sync the account through User Roles.
- Fix for when changing the status of a request as a specialist or supervisor, the requestor will receive the email.
- New reports – Community Studies (Civil Rights) Report, DMS Mitigation Request Report, Impact Summary Report, Jurisdictional Determinations Report and Jurisdictional Resource report.
- Permit Status Report – has notes sorted by date in reverse chronological order, included the division and region label, and various label names have been changed.
- When transferring a request from one person to an external requestor, the On Behalf of user should be selected.
- USFS report, Section 7 Surveys by Project report has had the notes length increased from 50 to 150.
- BSG Submerged Aquatic Vegetation requests now show notes on dashboard under internal details.
- On Behalf of transfer request – during transfer request, if we select external requestor as the requestor, then the internal requestor field is mandatory.

### Version 5.4.0 of ETRACS (7/16/2017) [build 5.4.4] includes:

A new way to create projects in ETRACS using the sub-TIP instead of the TIP to capture all the **project information, staff, and milestones from STaRS** regardless of WBS level.

**A new helpful Admin function** to allow ETRACS administrators to create new generic Work Request Types. Several reported bugs and small enhancements were also fixed.

#### [Version 5.0.0 of ETRACS \(4/23/2017\) build 5.0.4](#)

Version 5.0.0 of ETRACS is a major release. In addition to all the functionality of previous versions, ETRACS now has:

**Reports** that users can run on projects and requests. There will also be reports available for managers to show web activity, how many people are accessing ETRACS, what browsers and devices they are using, etc. More reports for projects and requests will be added in each future release.

Improvements to all the Cultural Resources requests: **Historic Architecture and Archaeology**.

For mobile work, people can use an **iPad** in the field. If you plan to use an iPad, please check out the system [prerequisites](#).

For user support, a new button has been added to the dashboard to get Help from the Users' Guide or from [ETRACSHelp@ncdot.gov](mailto:ETRACSHelp@ncdot.gov).

For **streamlining and usability**, requested improvements have been made to the dashboard, to error messages, to project information, and to the administrative functions. Several reported bugs were also fixed.

#### [Version 4.4.1 of ETRACS \(4/2/2017\) build 4.4.4](#)

Version 4.4.1 of ETRACS completes the Return Request function and fixes one reported bug.

#### [Version 4.4.0 of ETRACS \(3/26/2017\) \[build 4.4.2\]](#)

Version 4.4 of ETRACS includes all the functionality of previous versions, with the following enhancements and bug-fixes that have been added:

**Creating requests** will be faster because we've removed the step that required creating a "paper" memo and storing it with project documents. We've also streamlined the lifecycle of a request by removing the function of formally Returning Requests.

For **usability**, added an error message to alert users to contact [ETRACSHelp@ncdot.gov](mailto:ETRACSHelp@ncdot.gov) when they are not setup properly.

**Helpful Admin Tools:** a new function to allow work to be transferred from one requestor to another, as well as improved layout for usability on the User Role Maintenance screen.

**Corrections:** fixed several problems that were reported by ETRACS users, including: email problems, difficulties in submitting requests from In Draft or In QC status, and erroneous duplication of projects being created as both WBS and "Other" project types.

#### [Version 4.3.0 of ETRACS \(3/19/2017\) build 4.3.1\]](#)

Version 4.3 of ETRACS includes all the functionality of previous versions, with the following enhancements and bug-fixes that have been added:

For **usability**, a fix was made to the search/filter/sort function

For **Biological Surveys**, the organization of species by county was corrected to combine all counties under each species in a single survey

#### [Version 4.2.0 of ETRACS \(3/12/2017\) \[build 4.2.0\]](#)

Version 4.2 of ETRACS includes all the functionality of previous versions, with various bug-fixes and the following enhancements:

**Helpful Admin Tools:** simplified the roles for Webroles and ETRACS, optimized (sped up) the User Role setup function.

#### [Version 4.1.0 of ETRACS \(2/26/2017\) \[build 4.1.2\]:](#)

Version 4.1 of ETRACS includes all the functionality of previous versions, with the following enhancements and bug-fixes that have been added:

**Subtasks** are an existing function in ETRACS that allows discrete pieces of work to be assigned to consultants under contract. This release of ETRACS has enhanced this function by:

- Refining the information that will be displayed about consultants' work
- Allowing deletion of subtasks by appropriate people
- Distinguishing the appearance of project-level vs. request-level subtasks for usability
- Fixing the Subtask Search

For **usability**, added the name of the request type in the screens where the request is being updated or worked on.

**Admin Tools for the Business:** fixed several issues in the admin function

**Corrections:** fixed several problems that were reported by ETRACS users or reported in user and/or IT testing, including some BSG and ECAP changes.

#### [Version 4.0.0 of ETRACS \(2/5/2017\) \[build 4.0.5\]:](#)

Version 4.0 of ETRACS is the final release to bring all of the HES and NES groups online. This includes all of the functionality of previous versions, with the following functionality that has been added:

**All groups of the Natural Environment Section (NES)** have been added to ETRACS and are online for creating and completing all of their requests. This includes:

- Environmental Coordination and Permitting (ECAP)
- ICI/On-Site Mitigation
- Engineering

For **Biological Surveys**, added: a summary table for the dashboard, some new Results options to give more detail for their work, as well as other changes and enhancements as requested by this group.

For **usability**, a new dashboard design makes it easier to distinguish projects and requests from each other.

For other **enhancements**, added a Project Notes category for **Let Dates**. This should improve the communication concerning revisions to Let Dates in ETRACS.

For **Requesters**, made screen changes to clarify and expedite requests made by consultants so that they can be submitted without the Requestor's review. Each requestor can change that choice, as well as other individual preferences, using their user preferences under their ETRACS Settings.

**Admin Tools for the Business:** ETRACS Admins now have the ability to make corrections to the Request names, required documents, requested lead times for the work, etc. They use an Admin Tool that gives the business a powerful way to configure ETRACS and to be responsive to changing business needs over time.

[Version 3.0.0 of ETRACS \(12/11/2016\) \[build 3.0.3\]](#) includes:

All of the functionality of previous versions. The following functionality has been added:

**All groups of the Human Environment Section (HES)** have been added to ETRACS and are online for creating and completing all of their requests. This includes:

- Traffic Noise and Air Quality
- Community Studies
- Public Involvement

For **clarity**, brackets have been added to request types that have the same name for different groups, thus ensuring that the request reaches the right group. For example, [HA] is a prefix for some Historic Architecture requests, [A] is a prefix for some Archaeology requests, [CS] is a prefix for some Community Studies requests, [PI] is a prefix for some Public Involvement requests, and [TNAQ] is a prefix for some Traffic Noise & Air Quality requests. These are all needed because the name of the request is the same.

For **usability**, the order of the buttons on the Create Request screen is more logical, that is: Enter TIP# -> Verify -> Select WBS to Continue. Also for usability, it is now easier to remove Historic Architecture and Archaeology groups when they are not needed.

**Corrections:** the search function has been corrected so that it now filters out Project Type 3s correctly. We have also made some small corrections to wording/labels on the screens, as requested by the current users and the Core Team.

**Installed application:** with this new installation, it's a good idea to click Ctrl-F5 to refresh your browser the first time you log on. We apologize for the inconvenience; IT is working on a resolution to this possible issue to ensure that you get a clean install on your computer. As-of now, this is an unavoidable step given the multiplicity of machines in an organization of this size.

Version 2.0.0 of ETRACS (11/20/2016) [build 2.0.11] includes:

All of the functionality of previous versions. The following functionality has been added:

**Biological Surveys Group (BSG) of the Natural Environment Section (NES)** has been added to ETRACS.

They are now online for creating and completing all of their requests.

ETRACS now supports **Project Notes** to be created, as well as copied across projects. This will provide information at the project level, as well as a means for different groups to communicate.

As a first step for adding all of **NES and incorporating data that is available in the Data Warehouse**, ETRACS now includes new project-level information, such as Construction Let Date, additional staff names not available in STaRS, and a field for Requesting Unit (which is also required for Cultural Resources reporting). Users now have a choice whether or not to receive project update notifications.

New directions for linking to documents in a **SharePoint library** are included in every field that asks for a document link.

**Subtask** functionality has been enhanced, and subtasks can also be created at the project level.

**Additional project / bridge description** has been changed to be editable, even if it's a bridge project from STaRS.

For **clarity and appearance**, ETRACS has a new logo. All screens throughout the system cleanly show TIP/Sub-TIP/WBS on one line. The dashboard tabs have been changed to include design information within the other project general information.

**Corrections:** the search function has been corrected so that it now filters out Project Type 3s correctly. We have also made some small corrections to wording/labels on the screens, as requested by the current users and the Core Team.

Version 1.4.0 of ETRACS (8/28/2016) [build 1.0.31] includes:

All of the functionality of previous versions. The following enhancements were added:

For **supporting SharePoint document links**, ETRACS has been modified to recognize and process correctly all document links from both Project Store and directly from SharePoint.

For **clarity of communications & ease of lookup**, ETRACS notifications (emails and memos) will contain the complete project numbers, for example, TIP: A-0009 | Sub-TIP: A-0009FO | WBS: 4567.2.1.

For **improved search capability**, the blue Clear All button clears every field (not just the request status).

For **user ease of access**, a Google search for ETRACS will easily find the URL for our system.

For **user support**, ETRACS administrators will be able to delete requests so they can more easily help users with issues.

We have also made some small corrections to wording/labels on the screens, as requested by the project team.

**NOTE:** build 1.0.32 was a patch release to fix an email problem in Production. It also implemented an enhancement to allow a requestor to delete requests in status On-hold and Returned.

Version 1.3.0 of ETRACS (7/29/2016) [build 1.0.28] includes:

All of the functionality of previous versions. The following enhancements were added:

For **creating requests**, a third project type has been added to accommodate projects that:

- Share a WBS number, such as Division maintenance, spot safety, bridge, and rail projects
- Do not have a TIP or WBS number, such as commerce or municipal projects

For **editing requests**: Completed Requests can now be edited by any role; however, PA numbers can be edited only by supervisors.

For **project information**: ETRACS now allows Project Information to be edited by any role, and there is expanded space for describing the project Design Information.

For **searching** from the dashboard: the “Name” search now appears in alphabetical order.

For **user support**:

- Improved instructions for mapping to Project Store to facilitate storing and linking documents
- A new email [ETRACShelp@ncdot.gov](mailto:ETRACShelp@ncdot.gov) is available for users to request support.
- A Troubleshooting section has been added to the Users’ Guide that includes the difficulties that have been experienced by the users.

Version 1.2.1 of ETRACS (5/13/2016) [build 1.0.21] includes:

All of the functionality of V1.2. The following enhancement was added:

For User Roles administrative function: Improved performance of this function for ETRACS administrators

Version 1.2 (4/25/2016) [build 1.0.19] of ETRACS includes:

All of the functionality of V1.0. The following enhancements were added:

For Programmatic Agreement requests:

- Redesign of PA flow
- Changes to names of NEPA/SEPA documents and which enabled the PA flow
- Changes to NEPA/SEPA document defaults for enabling the PA# flow
- Added the functionality so that more than one person can get notifications of new PA requests

For documents:

- Removed functionality of common documents
- Improved clarity of which documents are input (in creating a request) and which documents are deliverables (for completing a request)

For the dashboard:

- Improved default dashboard view
- Show more information on the dashboard view of Request Details

For added functionality for roles:

- Allow supervisors to complete requests and update the actual completion date
- Allow both supervisors and specialists to update a subtask
- Allow post-dating results

For general usability:

- Added WBS descriptions for creating a request
- Added Users' Guide link to every page

Defect fixes for:

- User preferences for reviewing consultants' work
- Drive-mapping to the correct level in Project Store to accommodate differences for the Divisions

Version 1.0 of ETRACS (1/13/2016) includes:

- the basic system for creating projects and making requests from Project Development and Divisions
- the process flow for updating requests and adding details for both projects and requests
- the interfaces for pulling project data from STaRS and updating STaRS milestones.
- the definition of users by role, including supervisors and both internal and external requesters and specialists. This will allow controls for both system security and "personalized" ease-of-use of the system.
- the dashboard to allow each user to sort and search both projects and requests

Groups will be added iteratively as the system is built out. In this rollout version, requests can be made to:

- Archaeology
- Historic Architecture
