THIS AGREEMENT, entered into this the 23rd day of October 20 02 by and between the DEPARTMENT OF TRANSPORTATION, an agency of the State of North Carolina, hereinafter known as the DEPARTMENT, and Earl W. Goldston a/k/a Earl William Goldston, Sr. a/k/a E.W. Goldston ; and wife E.W.G.  
Blanche O. Goldston a/k/a Blanche Olive Goldston a/k/a Blanch Goldston

of the County of Chatham hereinafter known as GRANTORS.

**WITNESSETH**

THAT WHEREAS, the DEPARTMENT desires to construct and maintain a drainage facility through and across the property of GRANTORS,

AND WHEREAS, GRANTORS, recognizing the benefits accruing to their said property through the construction and maintenance by the DEPARTMENT of roads and highways upon or in the vicinity of said property of GRANTORS.

NOW, THEREFORE, in consideration of said benefits, and further consideration of \$ 1,125.00, and other valuable considerations, GRANTORS hereby release the DEPARTMENT, its successors and assigns, from any and all claims for damages by reason of the construction and maintenance of said drainage facility across and through and across the lands of GRANTORS, and GRANTORS hereby give, grant, bargain, sell and convey unto the DEPARTMENT, its successors, and assigns, an easement for the construction and maintenance of a drainage facility across and through the property of GRANTORS located in Gulf Township, Chatham County and being more fully described in a deed recorded in Book 243 Page 621, Book 248 Page 340, Book 342 Page 204, Book 342 Page 206, Book 342 Page 208, Book 356 Page 438, Chatham County Registry, said easement being described as follows:

Beginning at a point on the western existing right of way line of US 421 said point being 28.042 meters ( 92 feet) southwest of and normal to Survey Station 65+57 Survey Line L, thence southwesterly in a straight line to a point 36 meters ( 118.11 feet) southwest of and normal to Survey Station 65+57 Survey Line L, thence northwesterly in a straight line to a point 36 meters ( 118.11 feet) southwesterly of and normal to Survey Station 65+69 Survey Line L, thence northeasterly in a straight line to a point 28.042 meters ( 92 feet) southwesterly of and normal to Survey Station 65+69 Survey Line L, thence in a general southerly direction along the aforementioned existing right of way line to the point of beginning.

The final right of way plans showing the above described are to be certified and recorded in the Office of the Register of Deeds for said county pursuant to N.C.G.S. 136-19.4. reference to which plans is hereby made for purpose of further description.

This agreement is subject to the following provision only: None

There are no conditions to this agreement not expressed herein. GRANTORS, their heirs and assigns, hereby covenant to and with the DEPARTMENT that they are the sole owners of the hereinabove described property; that they solely have the right to grant this easement; and that they will forever defend the same against the lawful claims of all persons whomsoever.


