Subject:Right of Way Monumentation Field Verification

The right of way line that we establish on a highway project through the Transportation Improvement Program is some type of boundary line between the public (through NCDOT) and private property owners. As such it has to be monumented to match the official documentation of that boundary line. It is our responsibility to ensure that the right of way according to the recorded plans is monumented on the ground.

Beginning November 1, 2000, the set of right of way plans labeled "Final Right Of Way For Recordation" will carry an LS number. At the time of receipt of those plans, it is our responsibility to ensure that the ground monumentation matches that shown on this set of plans. I am requiring that a signed statement (sealed if by PEF) be sent in to this office for every set of plans for recordation, whether checked by PEF or in-house. This statement, labeled "For Plans To Be Recorded", accompanies this memo. The plans for recordation usually precede the Construction let by six weeks, which should be sufficient time to complete this LS activity. In no case should this activity extend beyond the date of beginning construction.

Attached to this memo you will find two certification documents, one labeled "For Preliminary or Revised Plans" and one "For Plans To Be Recorded". The Preliminary/Revised certification should be provided to and filled out by any PEF that stakes right of way for NCDOT. This certification should accompany any right of way staking performed by a PEF, along with a red-lined set of plans showing the type of monument staked (spike, IP&C, PK nail, etc.), and the date of setting the monument. You should maintain this set in your office at least until the time of receipt of plans for recordation.
