## **Project Budget, Sources and Uses of Funding**

The estimated project cost is \$57.7 million. MPDG funding is being requested to provide 44% of the project investment while the balance would be funded through state and Appalachian Regional Commission (ARC) Grant funds.

Table 1 shows funding sources for G2S, including \$25.2 million in proposed MPDG funds.

The total estimated project cost of \$57.7 million would include \$25.2 million in MPDG funding, \$2.5 million in Other Federal Funds committed by ARC, and \$30 million in non-federal funds appropriated by the NC Assembly. NCDOT's Certification of Financial Contribution, dated August 18, 2023, is provided in **Funding Commitments**.

There are no additional constraints or requirements in terms of expenditure period or satisfying other conditions. The funding plan does not include any other grants other than that proposed for MPDG.

A detailed preliminary construction cost estimate for G2S (\$57.7 million) is included as an attachment in grants.gov. The estimate was developed for the Alternatives Analysis and updated in July 2023 with present unit costs. Currently, design is at approximately 60% completion. A 20% contingency was applied to the cost estimate reflecting in part the transportation cost escalation trends NCDOT has been experiencing, anticipated market escalation, and inflation. Costs will be incurred over an expected three-year construction period beginning in 2023.

Pre-construction costs through June 2023 totaled \$2.9 million for preliminary design and environmental approvals.
