I am writing in reference to the application for funding submitted by the North Carolina Department of Transportation to the Large Bridge Project portion of the Bridge Investment Program to help fund the replacement of the Cape Fear Memorial Bridge in Southeastern North Carolina.

The Cape Fear Memorial Bridge serves as a critical junction for U.S. Highways 17, 76, 421, crossing the Cape Fear River connecting New Hanover and Brunswick counties. The bridge, with its two-tower vertical lift, has been an iconic fixture in our community for more than fifty years while facilitating the transport of goods brought to and from the Port of Wilmington in addition to the connectivity it provides for all who utilize it. Unfortunately, the bridge's capacity and aging lift structure is becoming functionally obsolete; recent inspections substantiate and underscore its need for replacement. I am writing to voice my support for the North Carolina Department of Transportation's (NCDOT's) application for a Bridge Investment Program, Large Bridge Grant to help fund the replacement of the Cape Fear Memorial Bridge.

The bridge serves US 17, US 76, and US 421, connects New Hanover County to Brunswick County. It was built over fifty years ago. I served on the Department of Transportation Board (under Governor Jim Hunt) and it was a grade F (over 16 years ago) Our region is growing so fast and the bridge is so old we make the replacement project imperative.

The proposed replacement is more than an infrastructure update. It will bring much needed operational and capacity improvements to meet existing and continuing transportation demands, as well as the region's first bicycle and pedestrian connection between Brunswick and New Hanover counties.

Potential additions to be considered:

- The project's potential to serve a historically disadvantaged community (as defined by USDOT demographic indices) and integrate with the historic neighborhoods along the river in the City of Wilmington.
- The bridge's role in promoting regional economic resurgence and its importance to the Port of Wilmington.
- The positive environmental implications of the new design, including reduced greenhouse gas emissions.
- The anticipated improvements in traffic safety and the corresponding benefits for the region's residents.
- The importance of this bridge for facilitating freight movements, underpinning its significance to the regional economy.

Having served on the NC State Ports board for eight year and as Vice President the bridge for the Port of Wilmington is significant for our state's economic activities and the most efficient port in North America, according to the 2022 Container Port Performance Index.

Another notable advantage of the new design will be its environmental and safety benefits. The proposed alternatives and design considerations harmonize with both regional and statewide infrastructure development goals, ensuring sustained and efficient traffic flow on one of North Carolina's key Strategic Transportation Corridors.

The project is an opportunity to direct significant infrastructure investment in a historically disadvantaged community, with disproportionate numbers of low-income households surrounding the bridge. These

communities face elevated natural hazard risks associated with flooding, and a new, more resilient bridge will serve a critical role in maintaining evacuation routes in case of an emergency.

New Hanover County and Brunswick County is growing so fast I have to wonder how long this bridge will last in its current state. New Hanover County is a tourism county. We have tourist coming in daily over the bridge.

I am asking for your consideration and support of the Cape Fear Memorial Bridge Replacement application for the receipt of MPDG grant funding.
