Why use a Combination Treatment?

Pavement Preservation treatments like Crack Seal, Chip Seal, and Micro Surfacing provide unique benefits:

- Crack Seal** fills and seals cracks from water and inert material.
- Chip Seal** provides a flexible, full-width sealant that protects and preserves the underlying surface.
- Micro Surfacing** provides a stiffer, full width sealant that protects the underlying surface with a smoother texture than Chip Seal.

However, when these treatments are used together, their longevity is extended by multiple years!

Cape Seal: Chip Seal and Micro Surfacing

Originating in Cape Town, South Africa, Cape Seals are a robust Pavement Preservation option that provides a flexible, crack retarding layer and a dark, smooth riding surface. Increased longevity and traffic bearing compared to a standalone Chip Seal.

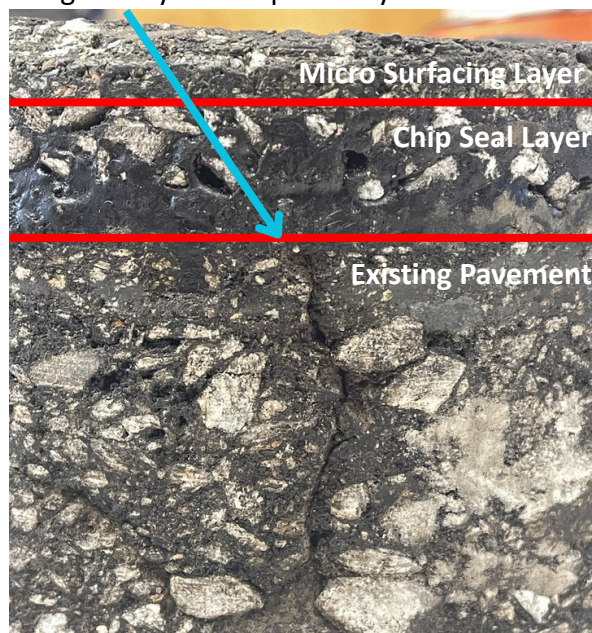
Crack Seal and Micro

Micro Surfacing performance is enhanced by a proper crack treatment. Crack Seal slows the reflection of existing cracks through the Micro Surfacing, reducing water penetration and debris buildup, which increases the longevity of your pavement.

Crack Seal and Chip Seal

Chip Seals can also be enhanced when used in tandem with Crack Seal. Division 6 uses this proactive approach: crack seal, followed by a Double Chip Seal 1-2 years later. This addresses each crack with a sealant, while also sealing and protecting the entire width of the road.
