- Attend your <u>Preconstruction meetings</u>.
- Host workshops in your Division if you need <u>Inspection training</u> or training on the AST 660 Form.
- A Pavement Preservation Team member can provide <u>on-the-job training</u> for your inspectors at the beginning of your project.
- We can help you ensure the <u>calibration and test strip</u> is performed properly on opening day.
- After work is complete, we can review maps that your staff flags as problematic or displaying issues.
- If issues with your Chip Seal appear during the <u>Warranty</u> period, we can also perform an investigation into the issue and potential causes.

PP Route and Treatment Selection

The success of your Pavement Preservation program begins with proper route and treatment selection.

PP Contract Development

If you are letting a PP contract, you will have to make design decisions, like shown below. We can help with that.

- AST Aggregate (rock) selection (78M, #9, #14, lightweight)
 - Example: see pictures to the right
- AST Emulsion and Aggregate Application Rates
- Fog Seal: Do I need it on my Chip Seal?
- Micro Surfacing Gradation Selection (Type II or Type III)
- Micro Surfacing Course Selection (Single, Double, Rut-fill)
