

A-0009 Crash Analysis Summary

As part of the NEPA process for A-0009, a crash analysis was performed for three sections in the study area including US 129, NC 143, and NC 28 in Graham County. The crash analysis included the study limits of the proposed project and was conducted using crash data pulled by Patriot Transportation Engineering (PTE) for a five-year period from December 1, 2014 to November 31, 2018. The data includes crash rates for total crashes, fatal crashes, non-fatal injury crashes, night crashes, wet crashes, and run-off road crashes. The crash rates were compared to the Statewide Average Crash Rates for the 5-year period of 2014-2018 for similar route types to see if the segment exceeded the statewide crash rates. The Critical Crash Rates for the segment were also calculated. The Critical Crash Rate is a crash rate that is statistically adjusted to account for exposure (traffic volume and segment length). For planning purposes, the calculation of the Critical Crash Rate uses a 95% confidence level. If the segment crash rate exceeds the critical crash rate, additional analysis may be considered to determine if treatable crash patterns exist.

US 129

Crash data was pulled for approximately 6 of miles US 129 (Tallulah Rd/Rodney Orr Bypass) from SR 1102 (Hares Creek Rd) to SR 1117 (Moose Branch Rd). Although a portion of US 129 is two lanes with a continuous left turn lane, the section was compared to a two-lane undivided section to be more conservative. A total of ninety-seven crashes were reported along the study section between December 1, 2014 to November 30, 2019. Based on the NCDOT Highway Safety Improvement Program warrants, a run-off road type crash is classified as run off road, fixed object, overturn/rollover, sideswipe opposite direction, parked motor vehicle, and head on crashes. The section of US 129 in the study area includes 18 run-off road type crashes including 13 fixed object crashes, 2 overturn/rollover crashes, 2 sideswipe opposite direction crashes, and 1 head on crashes. The crash rates for US 129 exceed the statewide rate for total and fatal crashes but do not exceed the critical crash rate. A summary of the crash types is shown below, and the crash analysis is included in Appendix A.

NC 143

Crash data was pulled for approximately 9 miles of NC 143 from US 129 (Rodney Orr Bypass) to NC 28 (Fontana Rd). A total of one hundred fifteen crashes were reported along the study section between December 1, 2014 to November 30, 2019. The section of NC 143 in the study area includes 52 run-off road type crashes including 1 run-off road crash, 38 fixed object crashes, 8 overturn/rollover crashes, 3

sideswipe opposite direction crashes, and 2 head on crashes. There were 30 run-off road crashes in a 3.7-mile section between the southern intersection of SR 1282 (Nathan Garland Rd) and NC 28 where there are multiple sharp curves in the roadway. Overall, run off road type crashes accounted for 45% of the total crashes on NC 143. The crash rates for NC 143 exceed the statewide rate for non-fatal, wet, and run-off road crashes but do not exceed the critical crash rate. A summary of the crash types is shown below, and the crash analysis is included in Appendix B.

NC 28

Crash data was pulled for approximately 7 miles of NC 28 from SR 1232 (Panther Creek Rd) to SR 1236 (Lower Sawyers Creek Rd). Although a portion of NC 28 is four lanes divided, the section was compared to a two-lane undivided section to be more conservative. A total of seventy-two crashes were reported along the study section between December 1, 2014 to November 30, 2019. The section of NC 28 in the study area includes 31 run-off road type crashes including 1 run-off road crash, 19 fixed object crashes, and 11 overturn/rollover crashes. Overall, run off road type crashes accounted for 43% of the total crashes on NC 28. The crash rates for NC 28 exceed the statewide rate for total, non-fatal, wet, and run-off road crashes. The crash rates for NC 28 also exceeded the critical crash rate for total crashes and run-off road crashes. A summary of the crash types is shown below, and the crash analysis is included in Appendix C.
