SUBJECT: Certifications Required for STIP Projects

To ensure that projects are prepared and ready for advertisement, the Department must review and document that bid packages are complete and that Right of Way acquisition, Utility relocation, and Railroad coordination has occurred, or that arrangements have been made for coordination during construction. Recent FHWA Compliance Assessment Program (CAP) reviews have noted improvements that are needed in these assurances for Division let projects – in the form of our ROW Certification, Utility Certification, Railroad Certification, and Plans Specifications & Estimate (PS&E) approval. These certifications and PS&E approval must be completed prior to construction funding authorization for all state and federally funded STIP projects.

This memo clarifies responsibilities for certifications and approvals for Division and Raleigh let projects as listed below. The Right-of-Way Field Certification form shall be completed by the Division Right of Way Agent for Division let projects and by the Division Right of Way Agent and Right of Way Manger for Raleigh let projects. The Utility Certification form shall be completed by the Division Utility Engineer or Division Construction Engineer if Division managed or by the State Utilities Manager if centrally managed. The Railroad Certification shall be completed by the Surfaces & Encroachments Manager in the Rail Division or the Project Manager for Division let projects and by the Surfaces & Encroachments Manager in the Rail Division for Raleigh let projects. It is best practice to coordinate with the Rail Division on any project with potential Railroad involvement. A PS&E Checklist, to be completed and signed by the Division Contract Officer, has been developed for Division let projects and will serve as the PS&E Approval document. The State Contract Officer will continue to certify PS&E Approval for Raleigh let projects.

The certifications should be complete when submitting the PS&E package. The certification documents shall be emailed to the Division of Planning & Programming – Project Management at <a href="FundingHelp@ncdot.gov">FundingHelp@ncdot.gov</a> 4 weeks prior to advertisement of Raleigh let projects. The certification documents, completed Division PS&E Checklist, and line-item estimate shall be attached to the AFRA construction funding request for Division let (DPOC) projects.

To ensure proper documentation, these certifications shall be stored on the project's Preconstruction SharePoint site. The Right of Way Certification shall be stored as a Key Document in the Right of Way Library. The Utility Certification shall be stored as a Key Document in the Utilities Library. The Railroad Certification shall be stored as a Key Document in the Rail Library.
