+NCDOT changed from a mainframe based inventory system to a more accurate GIS based inventory system in 2009. As a result, some system mileages are lower than the mileage reported in 2008. This data shift is primarily due to the higher precision and accuracy that the GIS based inventory system provides.

++From October 2014 through October 2016, NCDOT transitioned to a new LRS system and was on hold from making any changes to the data. There is no official mileage for 2015.

*Beginning in 2020, railroad and other public instrumentality mileage included in non-system mileage and primary and secondary route mileage that is maintained by federal agencies is excluded from State-Maintained mileage.

*In 2021, FHWA recommended removing publicly-maintained restricted access (gated) routes from public mileage. It is a work in progress but will result in a decrease in Federal mileage over time. This includes many routes on military bases.
