

Pursuant to that delegation, the Secretary of Transportation hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation, and in accordance with General Statute 136-30, 136-54.

NC ROUTE CHANGES

DIVISION 14

TRANSYLVANIA COUNTY

Delete the following routing of Secondary Road (no number assigned, previously NC 281), and add as NC 281, north of Lake Toxaway:

Secondary Road (Previously NC 281) from NC 281 (Previously SR 1306) north of Lake Toxaway, northward to its northern intersection with NC 281 (Previously SR 1306).

Delete the following routing of NC 281 (Previously SR 1306) and add as SR 1306, north of Lake Toxaway:

NC 281 (Previously SR 1306) from Secondary Road (Previously NC 281) north of Lake Toxaway, northward to its northern intersection with Secondary Road (Previously NC 281).
