This is in regard to your request for 53-foot semi-trailer truck access to the C & N Evans Trucking Company, Inc. terminal in Stoneville. Our investigation of you request is complete and approval is recommended. The approved routes are described below.

NC 14 from US 29 Business, an existing National Truck Network Route, at Reidsville to US 770 in Eden, then on US 770 from NC 14 to SR 1733, then on SR 1733 from US 770 to the Miller Brewing Company on SR 1733; and, continuing north on SR 1733 to SR 1797, then on SR 1797 from SR 1733 to SR 1715, then along SR 1715 from SR 1797 to Warehouse #1; and continuing north along SR 1797 from SR 1715 to Warehouse #2.

NC 87 from the Virginia line to NC 14, then along NC 14 from NC 87 to US 770 in Eden, then along US 770 from NC 14 to SR 1733, then on SR 1733 from US 770 to the Miller Brewing Company on SR 1733; and, continuing north on SR 1733 to SR 1797, then on SR 1797 from SR 1733 to SR 1715, then along SR 1715 from SR 1797 to Warehouse #1; and continuing north along SR 1797 from SR 1715 to Warehouse #2.


