The Board of Transportation has delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways pursuant to authority of N.C.G.S. 143B-250 (f), (g) (see 19ANCAC 4A.0004)

The State Traffic Engineer is subdelegated the authority by the Secretary of Transportation to adopt and promulgate all necessary rules, regulations and ordinances for the use of and to police traffic on state highways, pursuant to authority of N.C.G.S. 143B-350 (g) (see 19ANAC 4A.0004).

Pursuant to that delegation, the State Traffic Engineer hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation, and in accordance with General Statute 136-30, 136-54.

ROUTE CHANGES

DIVISION 1

MARTIN COUNTY

Delete the following routing of NC 44 and add as NC 111, west of and in Oak City:

NC 44 from the Edgecombe County Line eastward to the intersection of NC 11-NC 42.

DIVISION 4

EDGECOMBE COUNTY

Add the following routing of NC 122, in and east of Macclesfield:

NC 122-NC 124 from US 258 at Crisp westward to SR 1119 in Macclesfield.

Delete the following routing of SR 1119 and add as NC 122, in and between Macclesfield and Pinetops:

SR 1119 from NC 124 in Macclesfield northward to NC 42-NC 43 in Pinetops.

EDGECOMBE COUNTY

Delete the following routing of SR 1201 and add as NC 122, in and north of Pinetops:

SR 1201 from NC 42-NC 43 in Pinetops northward to SR 1202.

SR 1202 from SR 1201 northward to SR 1006.

Delete the following routing of SR 1006 and add as NC 111-NC 122, west of Tarboro:

SR 1006 from SR 1202 eastward to SR 1207.

Delete the following routing of SR 1207 and add as NC 122, west of Tarboro:

SR 1207 from SR 1006 northward to SR 1208.

Delete the following routing of SR 1208 and add as NC 122, west of and in Tarboro:

SR 1208 from SR 1207 west of Tarboro eastward to SR 1211 in Tarboro.

Delete the following routing of SR 1211 and add as NC 122, in Tarboro:

SR 1211 from SR 1208 eastward to US 64 Business.

Delete the following routing of US 64 Business and add as NC 33-NC 122 in Tarboro:

US 64 Business from SR 1211-SR 1557 (Howard Street) southward to SR 1006 (Wilson Street).

Delete the following routing of US 64 Business and add as NC 33-NC 111-NC 122 in and between Tarboro and Princeville:

US 64 Business from SR 1006 in Tarboro southward to SR 1558 in Princeville.

Delete the following routing of SR 1558 and add as NC 111-NC 122, in Princeville:

SR 1558 from US 64 Business to US 258-NC 44.

EDGECOMBE COUNTY

Delete the following routing of NC 44 and add as NC 111-NC 122 in Princeville:

US 258-NC 44 from SR 1558 eastward to the intersection of NC 44 and US 258.

Add the following routing of NC 122 in and east of Princeville:

US 258-NC 122 from NC 44 eastward to NC 122.

Delete the following routing of SR 1114 and add as NC 111, southwest of Pinetops:

SR 1114 from the Wilson County Line northward to SR 1201.

Delete the following routing of SR 1006 and add as NC 111, west of and in Tarboro:

SR 1006 from SR 1207 west of Tarboro northeastward to US 64 Business in Tarboro.

Delete the following routing of NC 44 and add as NC 111, in and east of Princeville:

NC 44 from US 258 eastward to the Martin County Line.

Delete the following routing of NC 44 and add as NC 33, in and between Whitakers and Tarboro:

NC 44 from the Nash County Line in Whitakers eastward and southward to US 64 Business in Tarboro.

Delete the following routing of US 64 Business and add as a secondary road, in Tarboro:

US 64 Business from US 64 Alternate southward to NC 44.

Delete the following routing of NC 44 and add as a secondary road, in Tarboro:

NC 44 (Northern Boulevard) from US 64 Alternate-NC 44 eastward to US 64 Business.

Delete the following routing of NC 44, in Tarboro:

US 64 Alternate-NC 44 from NC 44 (Northern Boulevard) southward to US 64-US 258.

US 64-US 258-NC 44 from US 258 in Tarboro eastward to the intersection of US 258-NC 44 and US 64 in Princeville.

Delete the following routing of NC 44, in Princeville:

US 258-NC 44 from US 64 eastward to SR 1558.

Delete the following routing of US 64 Business and add as NC 33 in and south of Princeville:

US 64 Business from SR 1558 in Princeville southward to US 64, south of Princeville.

Add the following routing of NC 33, south of Princeville:

US 64-NC 33 from US 64 Business southward to NC 33.

DIVISION 4

NASH COUNTY

Delete the following routing of NC 44 and add as NC 33, east of and in Whitakers:

NC 44 from NC 48 east of Whitakers eastward to US 301 in Whitakers.

Delete the following routing of NC 44 and add as NC 33, in Whitakers:

US 301-NC 44 from the southern intersection of US 301 and NC 44 to the northern intersection of US 301 and NC 44.

Delete the following routing of NC 44 and add as NC 33, in Whitakers:

NC 44 from US 301 eastward to the Edgecombe County Line.

WAYNE COUNTY

Add the following routing of NC 111, south of, in, and north of Eureka:

NC 222-NC 111 from NC 111 northward to the Wilson County Line.

DIVISION 4

WILSON COUNTY

Add the following routing of NC 111, south of and in Stantonsburg:

NC 222-NC 111 from the Wayne County Line northward to NC 58 in Stantonsburg.

Add the following routing of NC 111, in Stantonsburg:

NC 58-NC 222-NC 111 from NC 222 southward to NC 222-SR 1683.

Add the following routing of NC 111, in and north of Stantonsburg:

NC 222-NC 111 from NC 58-NC 222 in Stantonsburg northward to SR 1004, north of Stantonsburg.
