



**ORDINANCE ESTABLISHING SPEED RESTRICTIONS
ON A PORTION OF N. C. HIGHWAY 161**

THAT WHEREAS, the City of Kings Mountain, North Carolina, by General Statutes, is authorized to establish speed restrictions on those streets and highways which are a part of the City's Street System; and,

THAT WHEREAS FURTHER, by the General Statutes for the State of North Carolina, such ability to restrict the speed limits upon those streets and highways which might be located within the Municipal Corporate Limits and which are a part of the State Highway System is controlled by North Carolina General Statute §160A-297; and,

THAT WHEREAS FURTHER, it does appear that the North Carolina Department of Transportation has determined, based upon engineering and traffic investigation, that there should be certain speed limit modifications on a portion of Cleveland Avenue/N.C. Highway 161, that portion being located within the Municipal Corporate Limits for the City of Kings Mountain;

NOW, THEREFORE, BE IT ORDAINED by the City Council for the City of Kings Mountain, North Carolina, in Regular Session, assembled this the 27th day of August, 1996, as follows:

That from a point located on Highway 161, such point being 0.62 mile South of the Northern Corporate Limits of Kings Mountain, a point 0.43 mile North of State Road #2024, to a point 0.47 mile South of the Northern Corporate Limits of Kings Mountain, the maximum speed limit shall be 35 miles per hour; excepting that from 30 minutes before to 30 minutes after school begins and ends on school days, such maximum speed limit for vehicular traffic shall be 25 miles per hour.

This Ordinance shall be effective upon adoption.
