
Our investigation of your STAA reasonable access route request number 2164 for Coca Cola Bottling Company Consolidated is complete. At this time, we have found the following route to be acceptable by current traffic engineering standards and hereby grant approval for your firm to run all STAA-dimensioned vehicles along this route. The approved route is described as follows:

Reasonable Access Request No. 2164: Pitt County: SR-1579 (Staton Road) between the Coca Cola Bottling Company Consolidated terminal located at 1051 Staton Road and US 264, US 264 (NTN) between SR 1579 (Staton Road) and US 13/NC 11, US 13/NC 11 between US 264 and Edgecombe County line. Edgecombe County: US 13/NC 11 between Pitt County line and US 64, US 13/64 (NTN) between US 13/NC 11 and Martin County line. Martin County: US 13/64 (NTN) between Edgecombe County line and US 13/17 North, US 64 between US 13/17 North and Washington County line. Washington County: US 64 between Martin County line and the Coca Cola Bottling Company Consolidated terminal located at 823 US Hwy 64 E.

All weight limits that may exist on this above approved route must be observed.
