The Board of Transportation has delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways pursuant to authority of N.C.G.S 143B-350 (g) (see 19ANCAC 4A.0004).

The State Traffic Engineer is subdelegated the authority by the Secretary of Transportation to adopt and promulgate all necessary rules, regulations and ordinances for the use of and to police traffic on state highways, and to set, change, or extend route numbers on the Primary Highway System of North Carolina pursuant to authority of N.C.G.S 143B-350(g) (see 19ANCAC 4A.0004).

Pursuant to that delegation, the State Traffic Engineer hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation, and in accordance with General Statute 136-18 (5), 20-116 (h), 20-115.1 (b).


Dear Gentlemen:

Subject: Clarification of Signing Requirements for Truck Restriction Ordinances

This memo is to clarify signing requirements for truck restriction ordinances. In accordance with General Statute §20-116 (h), the Department may prohibit the use of "heavy trucks or other vehicles of a gross vehicle weight or axle load limit in excess of a designated maximum" on one route and designate another route of "approximately the same distance between two or more points" as a truck route. Ordinances enacted pursuant to this statute shall have signs posted in accordance with the statute.

Truck restrictions enacted under General Statute §20-115.1 (b) do not have a statutory or code requirement for signing, although some may be signed to improve compliance. Therefore, any ordinance package that contains the following verbiage:

"The Division Engineer for each affected Division shall cause to be erected appropriate signs indicating the action of the State Traffic Engineer and these ordinances shall be in full force and effect from and after the erection of such signs."

...applies to only those ordinances that have a statutory requirement to be signed and does not apply to truck restriction ordinances enacted under §20-115.1 (b). These ordinances become effective when the ordinance is passed and the restriction is published on the NCDOT web site and truck restriction maps are updated. See the attachment for a list of all ordinances in effect as of July 8, 2015 that were enacted under General Statutes §20-115.1 (b) since September 1, 2008 when Session Law 2008-221 (SB 1695) became effective that are not required to be signed by statute, and this clarification memo will be added to these ordinance packages for future reference.
