NC Route Changes

The following ordinance was introduced by Commissioner _____, seconded by Commissioner _____, and upon being put to a vote was duly adopted:

WHEREAS, it is in the public interest and is needed for direction of unfamiliar drivers and the simplification of signing; and

WHEREAS, it appears that certain changes and modifications should be made in the existing designation of NC route numbers;

NOW, THEREFORE, BE IT HEREBY ORDAINED that certain changes be made in the NC route numbered system as follows:

Division 3
Sampson County

Delete the routing of NC 403 along College Street in Clinton from SR 1855 (Warsaw Road) northeastward to US 701.

Division 12
Cleveland County

Delete the following routing of NC 226 in Shelby and return to the municipal street system:

NC 226 (Earl Road) from US 74 Bypass west to NC 226 (South Washington Street).

NC 226 (South Washington Street) from NC 226 (Earl Road) north to SR 2050 (East Graham Street).

Delete the following routing of NC 226 in Shelby:

NC 18N - 226N (South Washington Street) from SR 2050 (East Graham Street) north to US 74 Bus. - NC 150 (East Marion Street).

US 74 Bus. - NC 18N - 150 - 226N (East Marion Street) from NC 18N - 226N (South Washington Street) west to NC 18S - 150 - 226S (South Lafayette Street).

NC 18S - 150 - 226S (South Lafayette Street) from US 74 Bus. - NC 18N - 150 - 226N (East Marion Street) south to NC 18N - 226S (East Graham Street).

Division 12
Cleveland County - continued

Delete the following routing of NC 226 in Shelby:

NC 18N - 226S (East Graham Street) from NC 18S - NC 150 - 226S (South Lafayette Street) east to NC 18N - 226N (South Washington Street).

NC 18 - 226 (North Lafayette Street) from US 74 Bus. - NC 18N - 150 - 226N (East Marion Street) north to NC 226 (Lee Street).

Delete the following routing of NC 226 in Shelby and add as a Secondary Road:

NC 226 (Lee Street) from NC 18 - 226 (North Lafayette Street) west to the western corporate limit of Shelby a distance of 1.25 miles.

Delete the following routing of NC 226 and add as a Secondary Road:

NC 226 (Lee Street) from the western corporate limit of Shelby west to SR 1300, a distance of 0.75 mile.

Delete the following routing of SR 1300 and add as NC 226:

SR 1300 from NC 226 (Lee Street) south to US 74.

Add the following routing of NC 226:

SR 1300 from NC 226 (Lee Street) south to US 74.

US 74 from SR 1300 east to US 74 Bypass.

US 74 Bypass from US 74 east to the western corporate limit of Shelby, a distance of 0.17 mile.

Add the following routing of NC 226 in Shelby:

US 74 Bypass from the western corporate limit of Shelby east to NC 226 (Earl Road) a distance of 2.18 miles.

Scotland County

Add the following routing of NC 79:

From US 74, west of Laurinburg, along US 74 to US 15 - 401
Bypass, a distance of 0.6 mile.
