The following ordinances were introduced by Commissioner _____, seconded by Commissioner _____, and upon being put to a vote were duly adopted:

WHEREAS, it is in the public interest and is needed for direction of unfamiliar drivers and the simplification of signing; and

WHEREAS, it appears that certain changes and modifications should be made in the existing designation of NC route numbers;

NOW, THEREFORE, BE IT HEREBY ORDAINED that certain changes be made in the NC route numbered system as follows:

Division 1
Martin County

Add the following routing of NC 11:

Project 8.21557 from NC 125, in Oak City, northeast to Project 8.21111.

Project 8.21111 from Project 8.21557 northeast to the Bertie County line.

Division 1
Bertie County

Add the following routing of NC 11:

Project 8.21111 from the Martin County line northeast to Project 8.21114.

Project 8.21114 from Project 8.21111 northeast to SR 1126 at Woodville.

Division 1
Bertie County

Delete the following routing of SR 1126 and add as NC 11:

SR 1126 from Project 8.21114 northeast to NC 308 in Lewiston.

Division 1
Martin County

Add the following routing of NC 903:

NC 125 from NC 903 north to SR 1333 in Hamilton.

Delete the following routing of SR 1333 and add as
NC 903:

SR 1333 from NC 125, in Hamilton, north to Project 8.21111
(NC 11), 0.7 mile north of SR 1339.
