US-NC ROUTE CHANGES

The following ordinances were introduced by Commissioner \_\_\_\_\_, seconded by Commissioner \_\_\_\_\_, and upon being put to a vote were duly adopted:

WHEREAS, it is in the public interest and is needed for direction of unfamiliar drivers and the simplification of signing; and

WHEREAS, it appears that certain changes and modifications should be made in the existing designation of US-NC route numbers;

NOW, THEREFORE, BE IT HEREBY ORDAINED that certain changes be made in the US-NC route numbered system as follows:

Division 1  
Martin County

Delete the following routing of US 64 Bus. and add as US 17 Bus. South-US 64 Bus. West-NC 125 South in Williamston:

Main Street (US 64 Bus.) from Elm Street (SR 1436) to Haughton St. (NC 125).

Delete the following routing of SR 1436 and add as US 17 Bus. South-US 64 Bus. East-NC 125 South in Williamston:

Elm Street (SR 1436) from Main Street (US 64 Bus.) to Washington Street (US 17 Bus.-US 64 Bus.-NC 125).

Delete the following routing of US 17 Bus.-US 64 Bus.-NC 125 and add as US 17 Bus. North-US 64 Bus. West-NC 125 North in Williamston:

Washington Street (US 17 Bus.-US 64 Bus.-NC 125) from Elm Street (US 17 Bus. South-US 64 Bus. East-NC 125 South) to Haughton Street (US 17 Bus.-US 64 Bus.-NC 125).

Delete the following routing of US 17 Bus.-US 64 Bus.-NC 125 and add as US 17 Bus. North-US 64 Bus. West-NC 125 North in Williamston:

Haughton Street (US 17 Bus.-US 64 Bus.-NC 125) from Main Street (US 64 Bus.) to Washington Street (US 17 Bus. North-US 64 Bus. West-NC 125 North).

NOW, THEREFORE, BE IT HEREBY ORDAINED that certain changes be made in the NC route numbered system as follows:

Division 2  
Greene County

Delete the following routing of NC 58 south of Snow Hill:

NC 58-US 258 from its junction with US 258, south of Snow Hill to the Lenoir County line.

Delete the following routing of NC 91 north of Snow Hill:

Greene Street (US 13-258-NC 91) from Second Street (US 258-NC 91) northward to the north junction of US 13-258-NC 91, a distance of 0.5 mile.

Delete the following routing of NC 91 at Snow Hill:

Second Street (US 258-NC 91) from Greene Street (US 13-258) southward to its junction with US 258-NC 58.

Delete the following routing of NC 91 and add as NC 58 south of Snow Hill:

NC 91 from the junction of US 258, south of Snow Hill southward to the Lenoir County line.

Division 2  
Lenoir County

Delete the following routing of NC 91 and add as NC 58 in and north of Kinston:

NC 91 from the Greene County line to Vernon Avenue (US 70-258 Bus.) in Kinston.

Division 2  
Lenoir County - Contd.

Delete the following routing of NC 58 west of Kinston:

US 258-NC 58 from the Greene County line southward  
to US 70 west of Kinston.

Delete the following routing of NC 58 west of Kinston:

US 70 Byp.-258 Byp.-NC 58 from US 258 southward to  
US 70 Bus.-US 258 Bus. (Queen Street).

Add the following routing as NC 58 in Kinston:

Queen Street (US 70 Bus.-258 Bus.) from Vernon Avenue  
(US 70 Bus.-258 Bus.) southward to US 70 Byp.-258 Byp.
