

US ROUTE CHANGES

ADOPTION OF TRAFFIC ENGINEERING ORDINANCES

WHEREAS, the Board of Transportation has the authority to promulgate ordinances and is authorized to delegate the promulgation of ordinances to the Secretary of Transportation; and

WHEREAS, the Board of Transportation has authorized the Secretary of Transportation to adopt and promulgate on behalf of the Board of Transportation all necessary rules, regulations, and ordinances for use of, and to police traffic on highways; and

WHEREAS, the Traffic Engineering Branch has made the necessary traffic and engineering studies and that its recommendations have been recommended for approval by the Manager of Traffic Engineering Branch and the State Highway Administrator;

NOW, THEREFORE, the Secretary of Transportation hereby adopts and promulgates each ordinance attached hereto and labeled US ROUTE CHANGES

IT IS HEREBY ORDERED that the Division Engineer for each affected division shall cause to be erected appropriate signs when necessary indicating the action of the Secretary, and these ordinances shall be in full force and effect from and after the erection of such signs indicating the action taken by the Secretary.

US ROUTE CHANGES

Division 14

Macon County

Delete the following routing of US 23-US 441 and add as US 441 Business in Franklin:

US 23-441 (Georgia Road) from new project number 8.3064110, northward to Wayah Street.

US 23-441 (Wayah Street) from Georgia Street to Porter Street.

US 23-441 (Porter Street) from Wayah Street to Main Street.

US 23-441 (Main Street) from Porter Street, eastward to NC 28 (Harrison Avenue).

US 23-441, NC 28 (Main Street) from NC 28 (Harrison Avenue), eastward to the intersection of NC 28.

US 23-441 from NC 28, eastward to the intersection with US 441 Bypass, US 23.

Delete the following routing of US 64 and add as a Secondary Road west of and in Franklin:

US 64 from new project number 8.3064110, eastward to the intersection with US 441 Business, NC 28 (East Main Street).

Delete the following routing of US 64 in Franklin:

US 64, NC 28 (East Main Street) from the west intersection with NC 28, eastward to the east intersection with US 441 Business, NC 28.

US 64, NC 28 from NC 28 (East Main Street), southward to new project number 8.3023112.

Add the following routing as US 64 south of Franklin:

US 64 from old US 64, eastward along project number 8.3064110-8.3023112 to the intersection with NC 28.

Add the following routing as US 23-US 441 Bypass south of Franklin:

US 23-US 441 Bypass from old US 23-US 441, eastward along project number 8.3064110-8.3023112 to the intersection with US 441 Business, north of Franklin.
