US ROUTE CHANGES

Division 14

Jackson County

Delete the following routing of US 19A-23 and add as US 23 Business at Dillsboro:

US 19A-23 from the intersection with US 19A-441 - US 23-441, eastward to US 19A-23 East in Sylva.

Delete the following routing of US 19A-23 East and add as US 23 East Business in Sylva:

US 19A-23 East (Main Street) from the west intersection with US 19A-23 West, eastward to the east intersection with US 19A-23 West.

Delete the following routing of US 19A-23 West and add as US 23 West Business in Sylva:

US 19A-23 West (Mill Street) from the east intersection with US 19A-23 East, westward to the west intersection with US 19A-23 East.

Delete the following routing of US 19A-23 and add as US 23 Business in and east of Sylva:

US 19A-23 from the east intersection with US 19A-23 East - US 19A-23 West, eastward to New Project 8.2045501.

Delete the following routing of US 19A-441 and add as a Secondary Road in and west of Dillsboro:

US 19A-441 from New Project 8.2045501, eastward to the intersection with US 23-441 in Dillsboro.

Delete the following routing of US 19A-23 and add as a Secondary Road east of Sylva:

US 19A-23 from US 23 Business, eastward to SR 1449.

Add the following routing as US 19A-441 north of Dillsboro:

On Project Number 8.2045501 from old US 19A-441, eastward to New Project Number 8.3023111.

Add the following routing as US 23-441 in and north of Dillsboro:

On Project Number 8.3023111 from the intersection with US 19A-441 - US 23-441, northward to New Project Number 8.2045501.

Add the following routing as a Secondary Road in Sylva:

On Project Number 8.3023110 from US 19A-23 West, northward to New Project Number 8.2045501.

Add the following routing as US 19A-23 Bypass, north of Sylva:

On Project Number 8.2045501 from New Project Number 8.3023111, eastward to old US 19A-23.

Division 8

Montgomery County

Delete the following routing of SR 1103 and add as NC 731 west of Mount Gilead:

SR 1103 from the intersection with Project Number 6.803004, eastward to the intersection with SR 1107.

Add the following routing as NC 731 west of Mount Gilead:

One New Project 6.803004 from the Stanly County Line (at the Pee Dee River) east to SR 1103.
