HIGHWAY TRAFFIC ORDINANCES

The Board of Transportation by resolution dated July 24, 1973, delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways; pursuant to authority of N.C.G.S. 143B-350(a).

The Secretary of Transportation hereby adopts and promulgates the following ordinance based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation.

NC ROUTE CHANGES

Division 1

Pasquotank County

Delete the following routing of NC 34 and add as SR 1102 east of Weeksville:

NC 34 from a point 0.20 mile east of SR 1103, westward to SR 1103.

Delete the following routing of NC 34 in Elizabeth City:

US 17 Business-NC 34 from the south intersection of US 17 Business-NC 34, northward to US 158.

US 158-NC 34 (Elizabeth Street) from US 17 Business, eastward to the Camden County line.

Delete the following routing of NC 168 and add as NC 34 in Elizabeth City:

NC 168 (Ehringhaus Street-Water Street) from US 17 Business (Road Street), northeastward to US 158 (Elizabeth Street).

Add the following routing of NC 34 in Elizabeth City:

US 158 (Elizabeth Street) from NC 34 (Water Street), eastward to the Camden County line.
