BOARD OF TRANSPORTATION
HIGHWAY TRAFFIC ORDINANCES

The Board of Transportation has delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways pursuant to authority of N.C.G.S. 143B-350 (f), (g) (see 19ANCAC 4A.0004).

The State Traffic Engineer is subdelegated the authority by the Secretary of Transportation to adopt and promulgate all necessary rules, regulations and ordinances for the use of and to police traffic on state highways, and to set, change, or extend route numbers on the Primary highway system of North Carolina pursuant to authority of N.C.G.S. 143B-350 (f), (g) (see 19ANCAC 4A.0004).

Pursuant to that delegation, the State Traffic Engineer hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation, and in accordance with General Statute 136-18 (5).

US ROUTE CHANGES

DIVISION 01

TYRRELL COUNTY

Delete the following routing of US 64 Business:

US 64 Business (Main Street) from SR 1208 (Broad Street) to the western intersection of US 64 Business and US 64, west of Columbia.

Delete the following routing of SR 1208 (Broad Street) and add as US 64 Business:

SR 1208 (Broad Street) from US 64 Business (Main Street) to US 64.

DIVISION 05

DURHAM COUNTY

Delete the following routing of US 70 and add as US 70 Business in Durham:

US 70 from I-85 westward to the Orange County Line.

Add the following routing as US 70 Business in Durham:

Along Y-72 and Y-71 of Project 8.1414801 (I-306) from US 70 Business northward to US 70.

DIVISION 05

DURHAM COUNTY

Add the following routing of US 70 in Durham:

I-85/US 70 from US 70 westward to the Orange County Line.

DIVISION 06

COLUMBUS COUNTY

Delete the following routing of US 74-76 and add as NC 214:

US 74-76 from the beginning of Project 6.804459 (R-61), west of Bolton, to the end of Project 6.804459 (R-61), east of Bolton.

Delete the following routing of NC 214 and add as SR 1735:

NC 214 from US 74-76 to SR 1757.

Delete the following routing of SR 1757 and add as NC 214:

SR 1757 from NC 214 to US 74-76 Business at Whiteville.

Add the following routing of US 74-76:

Along Project 6.804459 (R-61) from its junction with existing US 74-76 west of Bolton to its junction with existing US 74-76 east of Bolton.

DIVISION 07

ORANGE COUNTY

Delete the following routing of US 70 and add as US 70 Business, west of Durham:

US 70 from the Durham County Line westward to I-85.

Add the following routing of US 70, west of Durham:

I-85/US 70 from the Durham County Line westward to US 70.

ALAMANCE COUNTY

Delete the following routing of US 70 in Haw River and add as a secondary road:

US 70 from the west terminus of Project 8.1470202, west of SR 1725 (Haw River Cemetary Road) eastward to the west intersection of US 70 and NC 49, a distance of 0.73 mile.

DIVISION 07

ALAMANCE COUNTY

Delete the following routing of US 70 in Haw River:

US 70-NC 49 from the west intersection of US 70 and NC 49 eastward to the east terminus of Project 8.1470202 at the east intersection of US 70 and NC 49, a distance of 0.90 mile.


Add the following routing of US 70 in Haw River:

Along Project 8.1470202 from the west terminus of the Project, west of SR 1725 (Haw River Cemetary Road), to the east terminus of the Project at the east intersection of US 70 and NC 49, a distance of 1.83 miles.

The foregoing Highway Traffic Ordinances are hereby adopted in accordance with the General Statutes of North Carolina (G.S. 136-18 (5); 143B-350 (f), 143B-350 (g) and 19ANCAC 4A.0004). The Highway Traffic Ordinances herein adopted are identified as follows:
