BOARD OF TRANSPORTATION  
HIGHWAY TRAFFIC ORDINANCES

The Board of Transportation has delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways pursuant to authority of N.C.G.S. 143B-250 (f), (g) (see 19ANCAC 4A.0004).

The State Traffic Engineer is subdelegated the authority by the Secretary of Transportation to adopt and promulgate all necessary rules, regulations and ordinances for the use of and to police traffic on state highways, pursuant to authority of N.C.G.S. 143B-350 (g) (see 19ANCAC 4A.0004).

Pursuant to that delegation, the State Traffic Engineer hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation, and in accordance with General Statute 136-30, 136-54.

**ROUTE CHANGES**

**DIVISION 4**

**EDGECOMBE COUNTY**

Delete the following routing of NC 122 in and east of Macclesfield:

NC 122 - NC 124 from NC 122 in Macclesfield eastward to US 258.

Delete the following routing of NC 122 and add as a secondary road, in Tarboro:

NC 122 (Howard Street) from US 64 Alternate eastward to NC 33 (Main Street).

Delete the following routing of NC 122, in Tarboro:

NC 33 - NC 122 (Main Street) from NC 122 (Howard Street) southward to NC 111 (Wilson Street).

**DIVISION 4**

**EDGECOMBE COUNTY**

Delete the following routing of NC 111 (Wilson Street) and add as a secondary road, in Tarboro:

NC 111 (Wilson Street) from US 64 Alternate eastward to NC 33 (Main Street).

Delete the following routing of NC 111 - NC 122, in and between Tarboro and Princeville:

NC 33 - NC 111 - NC 122 (Main Street) from NC 111 (Wilson Street) in Tarboro southward to NC 33 in Princeville.

Delete the following routing of NC 111 - NC 122 and add as a secondary road, in Princeville:

NC 111 - NC 122 from NC 33 southward to US 258.

Add the following routing of NC 122, in Tarboro:

US 64 Alternate - NC 122 from NC 122 (Howard Street) southward to NC 111 (Wilson Street).

Add the following routing of NC 111 - NC 122 in Tarboro:

US 64 Alternate - NC 111 - NC 122 from NC 111 (Wilson Street) southward to US 64 - US 258.

Add the following routing of NC 111 - NC 122 in and between Tarboro and Princeville:

US 64 - US 258 - NC 111 - NC 122 from US 64 Alternate in Tarboro eastward to US 64 in Princeville.

Add the following routing of NC 111 - NC 122 in Princeville:

US 258 - NC 111 - NC 122 from US 64 eastward to NC 111 - NC 122.

The foregoing Highway Traffic Ordinances are hereby adopted in accordance with the General Statutes of North Carolina (G.S. 136-18 (5); 143B-350 (f), 143B-350 (g) and 19ANCAC 4A.0004). The Highway Traffic Ordinances herein adopted are identified as follows:
