

BOARD OF TRANSPORTATION

HIGHWAY TRAFFIC ORDINANCES

The Board of Transportation has delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways pursuant to authority of N.C.G.S. 143B-350 (g) (see 19ANCAC 4A.0004).

The State Traffic Engineer is subdelegated the authority by the Secretary of Transportation to adopt and promulgate all necessary rules, regulations and ordinances for the use of and to police traffic on state highways, pursuant to authority of N.C.G.S. 143B-350 (g) (see 19ANCAC 4A.0004).

Pursuant to that delegation, the State Traffic Engineer hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation, and in accordance with General Statute 136-30, 136-54.

ROUTE CHANGE

DIVISION 4

JOHNSTON COUNTY

Delete the following routing of US 70 and add as US 70 Bypass, in and near Selma:

US 70 from US 70 Business west of Selma to US 70 Business east of Selma.

Delete the following routing of US 70 Business and add as US 70, in and near Selma:

US 70 Business from US 70 west of Selma to US 70 east of Selma.

Division 7

Rockingham County

Delete the following routing of NC 87 and add as a secondary road, south of and in Eden:

NC 87 from SR 1533 north to NC 770.

Delete the following routing of NC 87-770 and add as a secondary road, in Eden:

NC 87-770 from NC 87 east to SR 2066.

Delete the following routing of NC 87 and add as a secondary road, in and north of Eden:

NC 87 from NC 770 north to NC 14.

Delete the following routing of NC 770 and add as a secondary road, west of and in Eden:

NC 770 from SR 1533 east to NC 87.

Delete the following routing of NC 770 and add as a secondary road, in Eden:

NC 770 from NC 87 north to NC 700.

Delete the following routing of NC 700-770 and add as a secondary road, in Eden:

NC 700-770 from NC 770 east to NC 14.

Delete the following routing of NC 700 and add as a secondary road, in and north of Eden:

NC 700 from NC 770 north to NC 87.

Delete the following routing of NC 135 and add as a secondary road, west of Eden:

NC 135 from SR 1533 east to NC 770.

Delete the following routing of SR 1533 and add as NC 770, south of Eden:

SR 1533 from NC 770 east to NC 87.

Delete the following routing of SR 1533 and add as NC 87-770, south of Eden:

SR 1533 from NC 87 east to NC 14.

Add the following routing of NC 87-770 south of and in Eden:

NC 14-87-770 from SR 1533 north to NC 700-770.


Add the following routing of NC 87 in and north of Eden:

NC 14-87 from NC 700-770 north to NC 87.

The foregoing Highway Traffic Ordinances are hereby adopted in accordance with the General Statutes of North Carolina (G.S. 136-18 (5); 143B-350 (f), 143B-350 (g) and 19ANCAC 4A.0004). The Highway Traffic Ordinances herein adopted are identified as follows:
