BOARD OF TRANSPORTATION
HIGHWAY TRAFFIC ORDINANCES

The Board of Transportation has delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways pursuant to authority of N.C.G.S. 143B-350 (g) (see 19ANCAC 4A.0004).

The State Traffic Engineer is subdelegated the authority by the Secretary of Transportation to adopt and promulgate all necessary rules, regulations and ordinances for the use of and to police traffic on state highways, pursuant to authority of N.C.G.S. 143B-350 (g) (see 19ANCAC 4A.0004).

Pursuant to that delegation, the State Traffic Engineer hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation, and in accordance with General Statute 136-30, 136-54.

ROUTE CHANGES

Division 2

Beaufort County

Delete the following routing of NC 306 and abandon:

NC 306 from 0.26 mile northwest of SR 1941 northward to 1.55 miles south of SR 1004, a length of 4.75 miles.

Add the following routing of NC 306:

NC 306 from 0.26 mile northwest of SR 1941 northward to 1.55 miles south of SR 1004 along PCS Phosphate project (unnumbered), a length of 4.06 miles.

Revise the routing of SR 1945 to the following and abandon any other portions of SR 1945:

SR 1945 from a point 3.27 miles north of SR 1941 along PCS Phosphate project (unnumbered) to 1.87 miles northeast of PCS Phosphate project (unnumbered), a length of 1.87 miles.

Division 2

Pitt County

Delete the following routing of NC 33 and add as an extension of SR 1528:

NC 33 from 0.55 mile west of US 13-NC 11-903 eastward to SR 1527, a length of 0.75 mile.

Delete the following routing of NC 33 and abandon:

NC 33 from 0.55 mile west of US 13-NC 11-903 westward to 0.14 mile east of FAA AIP Project 3-37-0028-19.

Delete the following routing of NC 33 and add as new Secondary Road:

NC 33 from a point 0.13 mile east of SR 1401 along FAA AIP Project 3-37-0028-19 to 0.14 mile east of FAA AIP Project 3-37-0028-19, a length of 0.14 mile.

Modify the following routing of SR 1419:

SR 1419 from FAA AIP Project 3-37-0028-19, a point 0.45 mile east of SR 1440, northward to SR 1415, a length of 2.26 miles.

Add the following routing of NC 33:

NC 33 along FAA AIP Project 3-37-0028-19 from SR 1401 northeastward to US 13-NC 11-903 at intersection with SR 1579, a distance of 1.62 miles.

Add the following routing of NC 33:

US 13-NC 11-33-903 from intersection with NC 33 and SR 1579 southward to SR 1527, a distance of 0.32 mile.


Delete the following routing of SR 1527 and add as NC 33:

SR 1527 from US 13-NC 11-33-903 southward to intersection with SR 1528, distance of 0.69 mile.

The foregoing Highway Traffic Ordinances are hereby adopted in accordance with the General Statutes of North Carolina (G.S. 136-18 (5); 143B-350 (f), 143B-350 (g) and 19ANCAC 4A.0004). The Highway Traffic Ordinances herein adopted are identified as follows:
