
WHEREAS, the Town of Shallotte is of the opinion that the traffic conditions on the section of Smith Avenue (SR 1357), built as part of Transportation Improvement Project U-3462, between US 17 Business (Main Street) and NC 130 (Holden Beach Road) in the Town of Shallotte, are such that public safety would be improved by the assignment of a primary route number to it; and

WHEREAS, said road is under the jurisdiction of the North Carolina Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED that the Board of Aldermen of the Town of Shallotte hereby requests that the North Carolina Department of Transportation do the following:

- 1. Remove the designation of NC 130 from US 17 Business (Main Street) between SR 1357 (Smith Avenue) and NC 130 (Holden Beach Road);
- 2. Remove the designation of NC 130 from Holden Beach Road between US 17 Business (Main Street) and SR 1960 (Holden Beach Road) at Edgewater Drive; and
- 3. Assign the NC 130 designation to Smith Avenue (presently SR 1357) between US 17 Business (Main Street) and Edgewater Drive, NC 130 having already been assigned to Smith Avenue between Edgewater Drive and Holden Beach Road.
