

Route Number/s: US 21 Truck

County/s: Alleghany

Division/s: 11 TIP Project/s: R-4060/R-3117

General description of request (starting/ending points, etc.):

Create US 21 Truck from the starting point at the intersection of R-4060 and US 21, south of town, onto R-4060 and then onto SR 1206 (R-3117) to the the ending point at the intersection of SR 1206 and US 21, north of town. Maintaining the existing US 21, through downtown central business district, but restricting Truck traffic from turning on or off NC 18 in the downtown central business district.

Reason/Justification for this route change:

US 21 serves as a cross country route connecting Sparta and Alleghany County to I-77 to the south and Virginia to the north. This Truck Route would provide a bypass of the downtown central business district and allowing Truck traffic to travel on and off of NC 18 outside of downtown. The downtown contains lower speed zones, a school zone, crosswalks, traffic signals and on street parking causing concerns for safety as volumes increase.
