BOARD OF TRANSPORTATION

HIGHWAY TRAFFIC ORDINANCES

The Board of Transportation by resolution dated July 24, 1973, delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways; pursuant to authority of N.C.G.S. 143B-350(a).

The Secretary of Transportation hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation.

NC ROUTE CHANGES

Division 10

Mecklenburg County

Delete the following routing of SR 3822 and add as NC 16 North in Charlotte:

SR 3822 (E. 3rd Street) from NC 16 (Hawthorne Lane), northward to US 74-NC 27.

Add the following routing of NC 16 North in Charlotte:

US 74-NC 16 North-NC 27, from E 3rd Street, northward to NC 16 (Elizabeth Avenue).

Delete the following routing of NC 16 and add as NC 16 South in Charlotte:

NC 16 (Elizabeth Avenue) from US 74-NC 27, southward to NC 16 (Hawthorne Lane).

NC 16 (Hawthorne Lane) from NC 16 (Elizabeth Avenue), southward to NC 16 (Providence Road).

Division 10

Mecklenburg County

Add the following routing as NC 73 south of Cornelius:

NC 73 on New Project 8.2723403 from SR 2427, westward to NC 115.

NC 73-NC 115 from SR 2145, northward to NC 73 (Catawba Avenue), in Cornelius.

Delete the following routing of NC 73 in Cornelius:

NC 73 from the south intersection of NC 73-NC 115, northward to the north intersection of NC 73-NC 115, in Davidson.

Delete the following routing of NC 73 and add as a Secondary Road in and east of Davidson:

NC 73 from NC 115, eastward to New Project 8.2723403, at SR 2427.

NC ROUTE CHANGES

IT IS HEREBY ORDERED that the Division Engineer for each affected Division shall cause to be erected appropriate signs indicating the action of the Secretary, and these ordinances shall be in full force and effect from and after the erection of such signs.
