BOARD OF TRANSPORTATION  
HIGHWAY TRAFFIC ORDINANCES

The Board of Transportation has delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways pursuant to authority of N.C.G.S. 143B-350 (g) (see 19A1NCAC 4A.0104).

The State Traffic Engineer is subdelegated the authority by the Secretary of Transportation to adopt and promulgate all necessary rules, regulations and ordinances for the use of and to police traffic on state highways, pursuant to authority of N.C.G.S. 143B-350 (g) (see 19A1NCAC 4A.0104).

Pursuant to that delegation, the State Traffic Engineer hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation, and in accordance with General Statute 136-30, 136-54.

ROUTE CHANGES

DIVISION 11

WILKES COUNTY

Delete the following routing of NC 268:

NC 268, from a point approximately 0.31 mile west of SR 2026/SR 2300 eastward to the Surry County line, a point 0.24 mile east of SR 2026/SR 2300 (Length 0.55 mile)

Add the following routing as NC 268 Business:

-Y1- (SR 2026) on Project 8.1761301 (R-2604) from metric station 12+15.140, southward to metric station 13+54.599 at SR 2300. (Length 0.09 mile)

NC 268, from SR 2026/SR 2300, eastward to the Surry County line, a point 0.24 mile east of SR 2026/SR 2300 (Length 0.24 mile)

## ROUTE CHANGES

### DIVISION 11

#### WILKES COUNTY

Add the following routing as NC 268 Bypass:

-L- on Project 8.1761301 (R-2604) from metric station 10+85, a point approximately 0.27 mile west of SR 2026 eastward to metric station 21+15 at the Surry County line (Length 0.64 mile)

#### SURRY COUNTY

Delete the following routing of NC 268 and add it as NC 268 Business:

NC 268, from the Wilkes County line, a point 0.50 mile west of SR 1150, eastward to SR 1138 (Length 7.48)

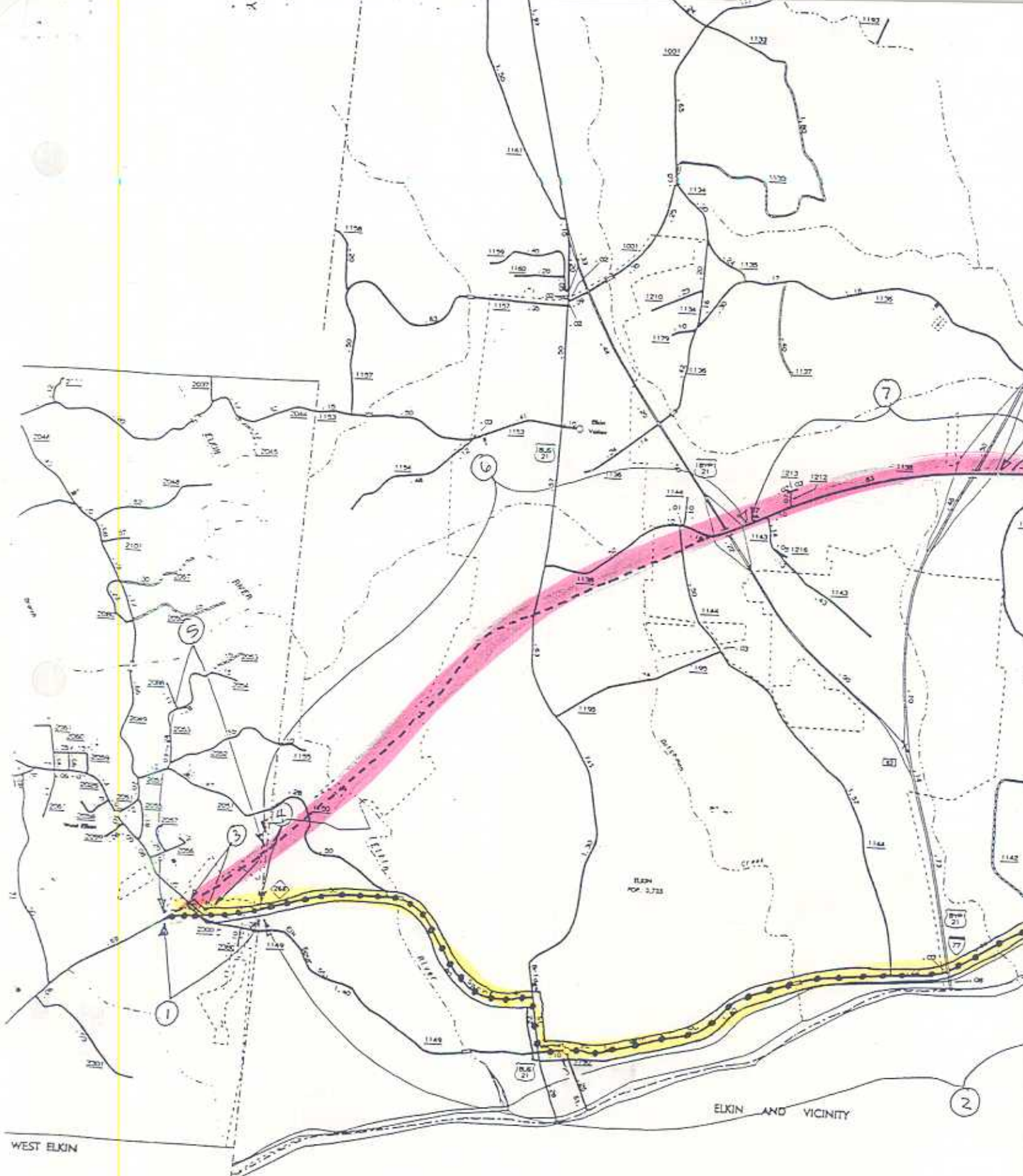
Add the following routing as NC 268 Bypass:

-L- on Project 8.1761301 (R-2604) from metric station 21+15 at the Wilkes County line, eastward to metric station 11+10, a point approximately 0.08 mile east of US 21 Bypass (Length 2.52 miles)

-LREV- (SR 1138) on Project 8.2741101 (R-2236), from metric station 11+10, a point approximately 0.08 mile east of US 21 Bypass, eastward to metric station 26+72, a point approximately 0.06 mile east of I-77 (Length 0.97 miles)

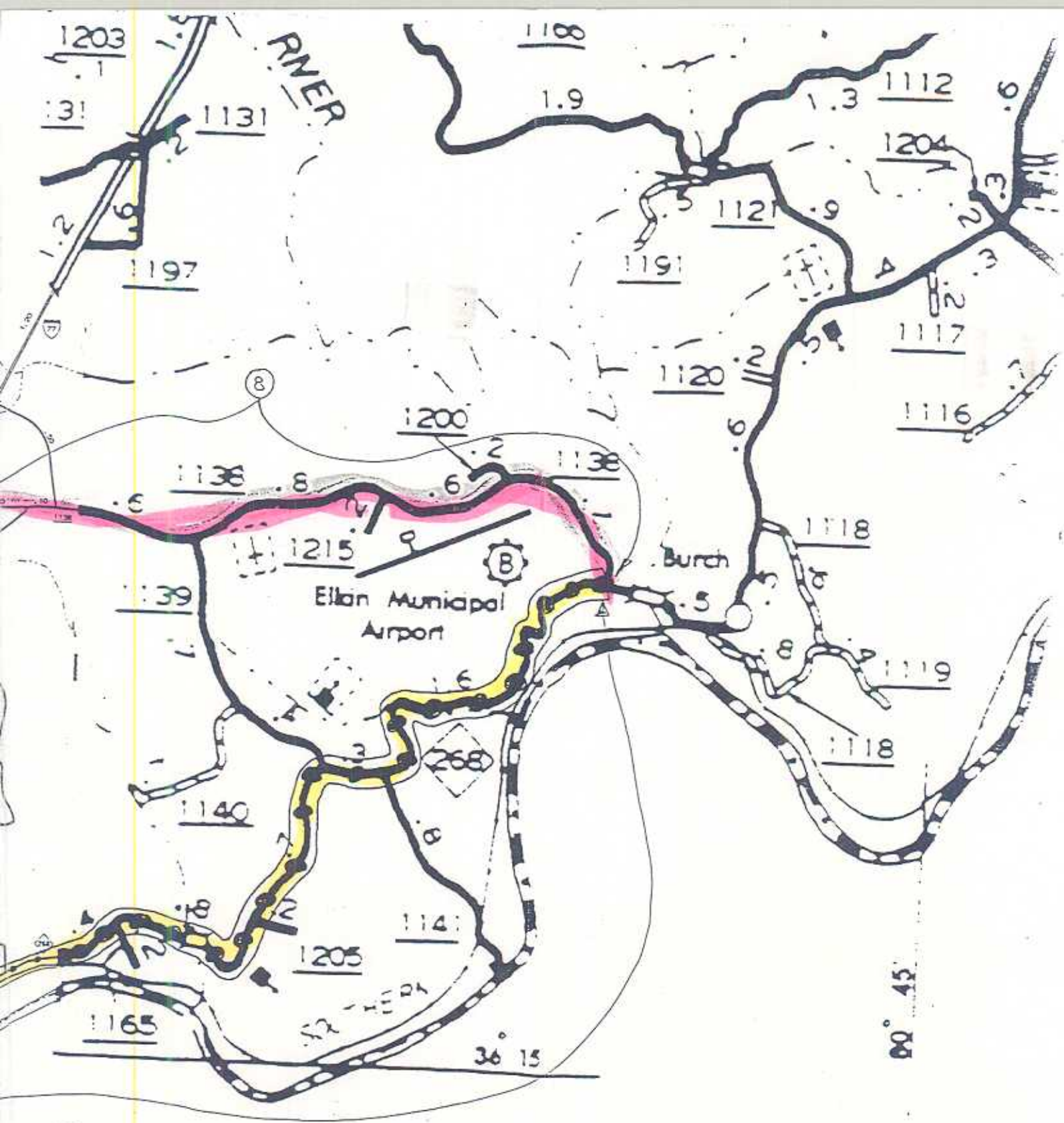
SR 1138, from a point approximately 0.06 mile east of I-77, eastward to NC 268 (Length 3.01 miles)
