The following ordinances were introduced by Commissioner \_\_\_\_\_, seconded by Commissioner \_\_\_\_\_, and upon being put to a vote were duly adopted:

WHEREAS, it is in the public interest and is needed for direction of unfamiliar drivers and the simplification of signing; and

WHEREAS, it appears that certain changes and modifications should be made in the existing designation of US route numbers;

NOW, THEREFORE, BE IT HEREBY ORDAINED that certain changes be made in the US route number system as follows:

Division 13  
Buncombe County

Correction for US 19-23 Route Description:

Delete the following routing of US 19-23:

US 19-23-25-70 from the junction of US 19-23-25-70, south of Weaverville, south to the junction with SR 1782 at New Bridge.

Add the following routing as US 19-23:

On project number 8.3023201 from US 19-23 at SR 1733, north of Weaverville, south to US 19-23-25-70 at the junction with SR 1782 at New Bridge, a distance of 5.3 miles.

US AND NC ROUTE CHANGES

WHEREAS, it is in the public interest and is needed for direction of unfamiliar drivers and the simplification of signing; and

WHEREAS, it appears that certain changes and modifications should be made in the existing designation of US and NC route numbers;

NOW, THEREFORE, BE IT HEREBY ORDAINED that certain changes be made in the US and NC route numbered systems as follows:

Division 6  
Cumberland County

Delete the following routing of NC 59 and add as US 401 Bypass:

NC 59 from its intersection with US 401 north of Fayetteville southwestward to its southwestern intersection with US 401.

Delete the following routing of NC 59:

US 401-NC 59 from NC 59 (Hope Mill Road) west to the southwestern intersection of current NC 59 with US 401 (Raeford Road).

Delete the following routing of US 401 and add as US 401 Business:

US 401 (Ramsey Street) from its intersection with present NC 59 north of Fayetteville, southward along US 401 (Ramsey Street) to US 401 (Gillespie Street).

US 401 (Gillespie Street) from US 401 (Ramsey Street) to US 401 (Russell Street).

US 401 (Russell Street) from Gillespie Street to US 401 (Robeson Street).

Delete the following routing of US 401 and add as US 401 Business:

US 401 (Robeson Street) from Russell Street southwestward along Robeson Street to US 401 (Raeford Road).

US 401 (Raeford Road) from US 401 (Robeson Street) westward to the southwestern intersection with current NC 59.

NOW, THEREFORE, BE IT HEREBY ORDAINED that certain changes be made in the NC route numbered system as follows:

Division 1  
Bertie County

Delete the following routing of SR 1200 and add as NC 11:

SR 1200 from NC 308 in Lewiston northeast to NC 305 at Connaritsa.

Division 8  
Montgomery County

Delete the following routing of NC 27A:

NC 27A from the intersection with NC 24-27-109 west of Troy southward to the intersection of NC 109 south of Wadeville, a distance of 3.3 miles.

Delete the following routing of NC 27A and add as a Secondary Road:

NC 27A from the intersection with NC 109 S. of Wadeville westward to the intersection with NC 73 at Pee Dee, a distance of 4.4 miles.

Delete the following routing of NC 27A:

NC 27A from the intersection with NC 73 at Pee Dee north-westward to the Stanly County line, a distance of 4.3 miles.

Randolph County

Delete the following routing of NC 49A and add as a Secondary Road:

NC 49A from the intersection with US 421 in Liberty to the intersection with US 220 in Balfour, a distance of 17.6 miles.

Randolph County - Continued

Delete the following routing of NC 49A:

NC 49A from US 220 in Balfour to its intersection with  
NC 42 in Asheboro, a distance of 1.8 miles.

Delete the following routing of NC 49A and add as SR 1004:

NC 49A from the intersection with US 220 Bus. in Asheboro  
to Park Street, a distance of 0.39 mile.

Delete the following routing of NC 49A and add as a  
Secondary Road:

NC 49A from the intersection with NC 49A and Park Street  
in Asheboro to the intersection with NC 49 in southwest  
Asheboro, a distance of 2.03 miles.
