✓ US and NC ROUTE CHANGES

The following ordinances were introduced by Commissioner _____, seconded by Commissioner _____, and upon being put to a vote were duly adopted:

WHEREAS, it is in the public interest and is needed for direction of unfamiliar drivers and the simplification of signing; and

WHEREAS, it appears that certain changes and modifications should be made in the existing designation of US and NC route numbers;

NOW, THEREFORE, BE IT HEREBY ORDAINED that certain changes be made in the US and NC route numbered system as follows:

US Route Changes

I - DURHAM COUNTY - US 501 and US 501 Business

- RK
- A. Remove the number US 501 beginning at its jct. with SR 1445 (Duke St.) in north Durham southward along its current routing (Roxboro Rd.) to its jct. with US 70-I 85 thence westward along US 70-I 85 to its jct. again with SR 1445.
 - B. Remove the secondary road number SR 1445 from its jct. with US 501 in north Durham southward along its current routing (Duke St.) to its jct. with US 70-I 85.
 - C. Assign the number US 501 along Duke St. from its jct. with US 501 in north Durham southward to its jct. with US 70-I 85.
 - D. Assign the number US 501 Business along the old routing of US 501 from its jct. with US 501 in north Durham southward along Roxboro Rd. to its jct. with US 70-I 85.

II - WILKES COUNTY - US 421-A

- A. Remove the number US 421-A from 10th St. in North Wilkesboro from its jct. with Forester Ave. and "A" St. northward to its jct. with "D" St., thence westward along "D" St. to its jct. with Forester Ave.
- B. Assign the number US 421-A North to the above sections of 10th and "D" Sts. in North Wilkesboro.
- C. Assign the number US 421-A South to Forester Ave. in North Wilkesboro from its jct. with "D" St. southward to its jct. with 10th St.

III. SURRY COUNTY - US 52 Business

- RK
- A. Remove the number US 52 Business from Main St. in Mt. Airy from its jct. with Hines Ave. southward to its jct. with Cherry St.
 - B. Assign the number US 52 Business South to the above section of Main St. in Mt. Airy.
 - C. Assign the number US 52 Business North in Mt. Airy to Cherry St. from its jct. with S. Main St. eastward to Renfro St., thence northward on Renfro St. to its jct. with Hines Ave., thence westward on Hines Ave. to its jct. with N. Main St.

IV. GASTON COUNTY - US 321

- RK
- A. Remove the number US 321 from Chester St. in Gastonia from its jct. with Airline Ave. (NC 7) southward to its jct. with York St.
 - B. Assign the number US 321 South to the above section of Chester St. in Gastonia.
 - C. Remove the secondary road number SR 2602 from York St. in Gastonia from its jct. with Chester St. northward to its jct. with Airline Ave. (NC 7)
 - D. Assign the number US 321 North to the above section of York St. in Gastonia and to Airline Ave. (NC 7) from its jct. with York St. westward to Chester St.

NC Route Changes

I. WILKES COUNTY - NC 18, NC 115, NC 268

- RK
- A. Remove the numbers NC 18 and NC 268 in North Wilkesboro from "B" St. from its jct. with 6th St. westward to its jct. with 10th St. thence southward on 10th St. to its jct. with Forester Ave. and "A" St.
 - B. Assign the numbers NC 18 North and NC 268 East to 10th St. from its jct. with Forester Ave. and "A" St. in North Wilkesboro northward to its jct. with "D" St.
 - C. Assign the numbers NC 18 and NC 268 to "D" St. in North Wilkesboro from its jct. with 10th St. eastward to its jct. with 6th St. thence southward on 6th St. to its jct. with "B" St.
 - D. Assign the numbers NC 18 South, NC 268 West, and NC 115 to "D" St. in North Wilkesboro from its jct. with 10th St. westward to its jct. with Forester Ave.

- E. Assign the numbers NC 18 South and NC 268 West to Forester Ave. in North Wilkesboro from its jct. with "D" St. southward to its jct. with 10th St.

II. SURRY COUNTY - NC 89

- A. Remove the number NC 89 from S. Main St. in Mt. Airy from its jct. with Pine St. southward to its jct. with Cherry St.
- B. Assign the number NC 89 South to the above section of S. Main St. in Mt. Airy.
- C. Assign the number NC 89 North in Mt. Airy to Cherry St. from its jct. with S. Main St. eastward to its jct. with Renfro St., thence northward on Renfro St. to its jct. with Pine St., thence westward along Pine St. to its jct. with Main St.
