BOARD OF TRANSPORTATION  
HIGHWAY TRAFFIC ORDINANCES

The Board of Transportation by resolution dated July 24, 1973, delegated to the Secretary of Transportation the authority to adopt and promulgate all rules and regulations and ordinances regulating traffic on the highways; pursuant to authority of N.C.G.S. 143B-350(a).

The Secretary of Transportation hereby adopts and promulgates the following ordinances based on traffic and engineering studies performed by the Traffic Engineering Branch, Department of Transportation.

NC ROUTE CHANGES

Division 11

Wilkes County

Delete the following routing of NC 18 South-NC 268 West and revert to Municipal System in North Wilkesboro:

NC 18 South-NC 268 West (Forester Avenue) from US 421 Business (D Street) to NC 18-268 (Wilkesboro Boulevard).

Add the following routing as NC 18 South-NC 268 West in North Wilkesboro:

NC 18 South-NC 268 West, from US 421 Business (D Street) along new CBD loop to NC 18-268 (Wilkesboro Boulevard).

Delete the following routing of NC 18 North-NC 268 East and add as a Secondary Road in North Wilkesboro:

NC 18 North-NC 268 East (10th Street), from NC 18-268 (Wilkesboro Boulevard) to US 421 Business (D Street).

Add the following routing as NC 18 North-NC 268 East in North Wilkesboro:

NC 18 North-NC 268 East from NC 18-268 (Wilkesboro Boulevard) along new CBD loop to 6th Street.

Add the following routing as NC 18 North-NC 268 East in North Wilkesboro:

NC 18 North-NC 268 East (6th Street) from CBD loop to US 421 Business-NC 18-268 (E Street).

NC ROUTE CHANGES

Division 13

Buncombe County

Delete the following routing of NC 694 and add as the US 70 eastbound off-ramp in Asheville:

NC 694 from US 70, eastward to SR 3599.

Delete the following routing of NC 694 and add as a Secondary Road in Asheville:

NC 694 from SR 3599, eastward to its junction with Project 8.1901405, on Pine Street.

Delete the following routing of SR 3599 and add as NC 694 in Asheville:

SR 3599 on Project 8.1901405 from Poplar Street, northward to Woodfin Street.

Add the following routing of NC 694 in Asheville:

Charlotte Street from Woodfin Street, northward to US 70.

On Project 8.1901405 from NC 694 (Charlotte Street), eastward to existing NC 694 at the end of Project 8.1901405.

NC ROUTE CHANGES

IT IS HEREBY ORDERED that the Division Engineer for each affected Division shall cause to be erected appropriate signs indicating the action of the Secretary, and these ordinances shall be in full force and effect from and after the erection of such signs.

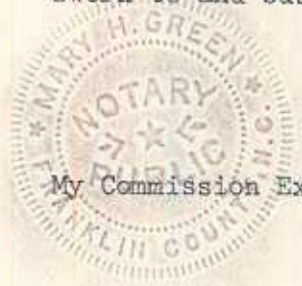
