SUBJECT: New State Law - Motorists Must Burn Headlights When Using Windshield Wipers in Inclement Weather

The 1990 General Assembly enacted a new law requiring motorists to burn headlights when driving in inclement weather, which requires the use of windshield wipers.

We have designed a new sign: "STATE LAW BURN HEADLIGHTS WHEN USING WINDSHIELD WIPERS" (R5-20) in two different sizes for use at State lines. The larger sign 48" x 60" is for use on Interstate and other freeway routes, and 30" x 42" is for use on conventional roads and expressways. Copies of the sign designs are attached for your information and use. This sign was discussed at the Operations Staff Meeting on August 8, 1990.

The signs need to be ordered and installed before October 1, 1990. This is the effective date for the new law. Please have the signs installed in the State line series on all roads with similar signing. It may be necessary to relocate one or more signs in the series in order to position these signs in proper sequence with the other "STATE LAW" signing.

In addition to installing these signs at the State line, they should be installed at airports where rental cars are available to the general public.
