Use of Private Vehicles for Official Business

Recent changes have brought about the need to update our guidelines for employees using their private vehicle for official business.

One change has been made to the classifications approved for routine use of private vehicles to include Division Project Team Leads.

Please keep in mind that a copy of any request to use a personal vehicle will no longer need to be sent to the Chief Engineer's Office. The Director of Field Support is no longer responsible for maintaining an inventory of all employees authorized to drive their private vehicles. Each Unit/Division will now be responsible for maintaining their own inventory.

#### **GUIDELINES FOR USE OF PRIVATE VEHICLES FOR OFFICIAL BUSINESS**

Specific approval is not required by Chief Engineer for each individual allowed the privilege of routine use of a private vehicle for official business. All requests for approval will be made to the appropriate supervisor via a letter containing all provisions listed in the attached sample letter. Unit Heads and Division Engineers are responsible for approving requests from their eligible subordinates. The Deputy Chief Engineer will approve requests of the Division Engineers.

It is the approving supervisor's responsibility to make certain the vehicle to be furnished is appropriate for the job responsibility. Full size extended cab pickup trucks are allowed. However, they must be capable of carrying four adults with all passengers facing forward.

Mileage logs, as required by the terms of the sample letter, will be those as furnished by Motor Fleet Management, or equivalent. If deemed appropriate, individual supervisors may require more detailed information. The mileage log will be retained in the Unit/Division offices as source documents for audit purposes.
