Dear Dr. Bruton:

In December of 1991, the NC Department of Transportation (NCDOT) agreed to become a partner with the Wildlife Resources Commission and others, in the development of the North Carolina Watchable Wildlife Viewing Guide and Program (copy attached). This Program was initiated with the publication of the Viewing Guide listing 95 sites across North Carolina that presented opportunities for wildlife viewing. A major component of this Program was the installation of highway signing to direct travelers to the viewing sites. As a project sponsor, NCDOT agreed to provide and install the necessary signs to furnish proper directions to the sites.

The Viewing Guide has now been published (copies enclosed) and we have completed preparation of the maps necessary to guide NCDOT staff in the placement of the signs. Enclosed are copies of the maps for all sites and information regarding the sign logos and recommended sign specifications. We would appreciate your assistance in forwarding these materials within NCDOT to departmental staff responsible for installation of the signs.

Signing

Two types of signing — directional and interpretive — should be used at a site.

Piractional Signing

Four basic types of directional signs exist, each of which includes the binoculars logo (see Fig. 1). The first sign is used on the interstate highway exit nearest the viewing area (see Fig. 2, Item A — note the "Tune Radio to 530 AM" is omitted where not appropriate). The second sign (Fig. 2, Item B) is posted at the major state highway intersection nearest the viewing site. The third sign is the binoculars logo accompanied by a directional arrow sign, and the fourth sign is the binoculars logo, directional arrow, and educational plaque reading "Wildlife Viewing Area" (see Fig. 3).

The binoculars logo is used for site identification if no other signing is posted and is also used as a trailblazer, leading the motorist from a highway intersection to the viewing area. In addition, the smaller logo signs (6" \times 6" to 12" \times 12") are for use along hiking trails, as appropriate. The Federal Highway Administration has adopted the binoculars logo as the international wildlife viewing symbol, and will be included in the *Manual of Uniform Traffic Devices*.

Funds for directional signing are usually provided by the site owner, manager, highway department, or appropriate legal subdivision.

Sign Specifications

Materials: No standards are established for panel materials due to the variability of agency specifications, as well as installation and maintenance cost. Where wood is used, 3/4" high-density plywood is recommended. Where aluminum is used, a minimum 0.08 thickness is recommended. Plastic composition materials may offer greater durability and decreased maintenance.

Screening: High-intensity grade reflective sheeting is recommended where traffic is highway speed and highest reflectance level is required. Engineering grade reflective sheeting is appropriate for sites where a lower level of reflectance is required.

<u>Colors</u>: All lettering, arrows, borders, and figures should be in white, while all sign backgrounds should use the standard brown (Federal Standard 595A Color Chip #20059).

Additional specifications for these signs are displayed in Figures 1,2, and 3.
