STANDARD VARIANT NAMING

PURPOSE OF POLICY

Variants are used in SAP PS Structure Reports to assist the users by populating values into a report selection or column selection input fields so that the report will display in the same format each time the user executes the report. The purpose of this policy is to establish a standard naming convention for the report variants.

Standardization of report variant naming will allow for:

- (1) Consistency and uniformity;
- (2) Enhanced search capabilities;
- (3) Business Unit ownership;
- (4) Efficient variant re-creation during future SAP upgrades.

STANDARD VARIANT NAMING

For the purposes of the policy document, variants will be classified by two types: (1) Global and (2) Unit Specific. Global variants can be used by the Department as a whole; i.e. 12 month let list, etc., however their creation is restricted by user permissions. Unit Specific variants can be created by anyone, but they should be controlled by each Business Unit. In either variant type, the number of characters is limited to 14.

GLOBAL

Global variants shall always begin with a "/DOT". The remaining ten characters will be at the discretion of the creator, but they should allude to the variant's intended use. The short description, which is limited to 30 characters, will give the user a better idea of the function of the variant.

Some possible examples:

Variant name	Short description	
/DOT 6MO_RW	6 month R/W report	
/DOT 12MLL	12 month let list	
/DOT 2009CP	List of 2009 Concurrence Pts.	

UNIT SPECIFIC

Unit Specific variants shall always begin with a standard Business Unit prefix as shown in the table. As with the global variants, the remaining eleven characters will be at the discretion of the creator with guidance from the Business Unit. Each Business Unit will determine how it will control and standardize the creation of each variant.
